SECTION III: NARRATIVE

BILL SUMMARY

Synopsis:

SB 323 amends the controlled substances act, possession prohibited section as follows:

- 1. Possession of up to on half ounce will be assessed a penalty of \$50.00.
- 2. Possession of half an ounce to an ounce is guilty of a petty misdemeanor and will be assessed a fine from \$50.00 \$100.00 dollars and up to 15 days in jail. Second offense is a misdemeanor with a fine of \$100.00 \$1000.00, or a term of imprisonment for a definite term up to a year, or both.
- 3. Possession of more than one ounce but less than eight ounces is guilty of a misdemeanor and will be assessed a fine from \$50.00 \$100.00 dollars and up to 15 days in jail. Second offense is a misdemeanor with a fine assessed of \$100.00 \$1000.00, or a term of imprisonment for a definite term up to a year, or both.
- 4. Possession of eight ounces or more is guilty of a fourth degree felony and sentenced pursuant to NMSA Section 31-18-15.
- 5. The sentencing and penalty assessment for synthetic cannabinoids is the same as is set out above for marijuana.
- 6. Possession or use of drug paraphernalia is subject to a penalty assessment of \$50.00.

The penalty assessment section of the bill decriminalizes possession of marijuana or synthetic cannabinoids for less than half an ounce, and decriminalizes possession of use of drug paraphernalia.

Section 3 of the Statute is new in its entirety and regulates the penalty assessments and timing of payments. Persons given a penalty assessment are offered either payment or court. Warnings Officers may still issue warnings to persons found to be in possession of under an ounce or of drug paraphernalia. See Pgs. 9-11.

Albuquerque and Santa Fe city councils have already decriminalized possession of marijuana

under an ounce. This law provides parity with municipal ordinances and state law.

FISCAL IMPLICATIONS: The prior bills listed above mirror the SB introduced. LOPD, AOC and OAG all commented on the significant reduction of cases to the District Attorneys and public defenders, and the less of a strain on the court system.

WHAT WILL BE THE CONSEQUENCES OF NOT ENACTING THIS BILL:

Enacting the bill is a manner in which to deal with a petty misdemeanor but not clog the court with small actions. It provides the person possessing marijuana drug paraphernalia or cannabis the option of paying a fine, acknowledging the illegality of the action but not requiring a public defender or appearance at court.
