### **SECTION III: NARRATIVE**

#### **BILL SUMMARY**

## Synopsis:

SB 27 creates within the Crime victims reparation committee to review any child abuse homicides. To review how state agencies responded and how it is that the state agencies can work together to prevent further types of homicides. The Committee calls for a member of AODA to be on Committee/Team.

The Statute further covers protection from liability to members of the Team and any persons who provide information either through testimony or documentation. It identifies documents and testimony as confidential given for the purpose of furthering the goal of the team.

The Act requires reporting of the findings to Governor, legislators, supreme court and directors of agencies.

### Analysis:

The genesis for this idea undoubtedly has come from the death of the minor child in Albuquerque. The team is a positive idea in that it includes multiple agencies that by working together could perhaps initiate lines of communication between agencies, and planned approaches to possible scenarios that could lead to homicides where an interagency approach could prevent. Such communication could perhaps preclude further homicides.

It is difficult to attain a monetary impact on the AODA, in that how many times the team meets is dependent on child abuse homicides, which is unknown. Also there is not a budget afforded to the Team to cover costs of time, and costs associated with the testimony and review of documentation they are required to do as part of their duties. Lack of funding could preclude any team meetings and or investigations.

A possible addition to this bill would be a clause that each team member sign a confidentiality agreement and any documentation provided or testimony given such person or agency be given a confidentiality agreement.

#### FISCAL IMPLICATIONS

THERE IS NO FUNDING ALLOCATED FOR THIS BILL AND THIS REVIEW TEAM.

Specifically with respect to AODA, a member of the agency would need to be on the committee. The amount of time taken from this employee's other duties is dependent on the number of homicides and how many times the review team is required to meet.
