# Amendment Synopsis:

The amendment added by Senate Judiciary:

- 1. The subparagraph of elements that do not constitute a defense in situations when the defendants response or knowledge of a victim's sexual identity may not be submitted as justification for the conduct of the defendant. The following two sections are deleted from such section:
  - a. Sufficient provocation with respect to the conduct for which the defendant is being prosecuted.
  - b. Evidence of the defendant's diminished responsibility for the defense by reason of mental disease or defect.

c. Evidence that the defendant acted in defense of the defendant's self or of another person.

#### **SIGNIFICANT ISSUES:**

Coined as the "panic defense," there have been cases throughout the nation, and in New Mexico where defendants attempted to use the victims gender identity as a basis for committing the crime. In 1996, Arthur "Bozo" Lopez, murdered Noah Rodriguez. Defendant stated he killed him as a result of an unwanted sexual pass made by Victim. The jury hung the first time with eleven members of the jury concluding a verdict of guilty and the second jury with a conviction.
