BILL SUMMARY

SB 196 is an appropriation to Public Defender Department for exploring the option of creating an innocence and justice project or other needs the department may have.

As background, The Innocence Project, begun in 1992 by Barry Scheck was begun to assist those persons wrongly accused of crimes. The burgeoning of DNA evidence and a Department of Justice Study citing eye-witness evidence was often incorrect brought the need for such an organization to light. In New Mexico, the UNM law Clinic has an innocence and justice project that is a not for profit. The UNM program is the only one in the state that does an in-depth investigation and coordinates DNA analysis for those wrongfully convicted of a crime.

SIGNIFICANT ISSUES

Language allowing funding for use in public defender department for "other needs" is unduly vague. Tying the appropriation for appeals or investigation of Innocence and Justice cases or perhaps contract work would protect the appropriation from undue legal challenge.
